COURSE DESCRIPTION

One of the beautiful facets of Islām is that it provides complete guidance for all aspects of daily life. Islāmic law, which developed gradually, is based on the teachings of the Holy Qur'ān, Sunnah, and Ahadith. The Promised Messiah^{as} is a judge and just arbiter of this era; he revived Islām and elucidated the misconceptions in Islām. In this course students will study “Fiqh Ahmadiyya” and select topics from the book “Fiqhul-Masih”, a compilation of the sayings of Hazrat Mirza Ghulām Ahmad, on whom be peace. This course provides knowledge of Islāmic Law. It will cover the introduction and sources of Fiqh Ahmadiyya, Fiqh & its four Imams, all the matters related to prayer, marriage, divorce, issues of children, inheritance etc. Therefore, it is the duty of every Ahmadi man or woman to adopt the method which has been pointed out by the ardent devotee of the Holy Prophet^{saw}. The Promised Messiah^{as} has explained it as per the guidance he received from Allah the Exalted, which has been mentioned in his own words.

- Comprehend the foundations and sources of Fiqh Ahmadiyya, exploring its origins and evolution.
- Study the teachings and methodologies of Fiqh & its four Imams, understanding their contributions to Islāmic jurisprudence.

- Demonstrate insights into the Divine guidance received by the Promised Messiah^{as} from Allah, examining his explanations and elucidations in his own words.
- Implement the knowledge in their lives and act as a guide for the community members.
